Re: Petition to name road

This letter has been written to you in response to your request to rename or name a street. In accordance with County Code 62-2(e), property owners may petition for a street name of their choosing. To be considered, seventy-five percent of the property owners must sign the petition. Also **County Code 62-2(a) No new street name shall duplicate or be similar to another street name.** Please be aware that any street name changes also cause a change in the resident's address. In accordance with **County Code 62-2(b) and 62-4(a) except in the case of absolute dire need and emergency, no such change shall go into effect until all affected property owners have been given a 160 day written notice.**

Please find enclosed the required Petition form and a map. Please mark the location of house locations on the enclosed map and return it to this office.

Once the necessary information is gathered and the form returned to this office, the street may be considered for the requested name change. If the requested information is not returned within **30 days**, or if the required percentage of **property owners do not agree** to a name change one may be selected by the GIS and E-911 Addressing.
