The APPLICANT hereby further understands and agrees that as consideration for the issuance of any grading permit, the APPLICANT shall indemnify and save harmless any person, persons or corporation, the COUNTY, its departments, agencies and designated agents from any and all actions, claims and damages which the COUNTY or any person, persons or corporations may now or hereafter have on account of any work done by or for the APPLICANT which fails to meet minimum requirements as set forth in the County Sediment Control and Stormwater Management Ordinance.
