- Copy of State Fire Marshall Inspection (DSFM)
- Proof and copy of liability insurance
- Lease agreement or statement from property owner granting permission for seasonal operation(s)
- Application Fee (\$100.00 per a permit)

### **Shaved Ice Stand**

- Site Plan
- Lease agreement or statement from property owner granting permission for seasonal operation(s)
- Application Fee (\$100.00 per a permit)

### **Seasonal (i.e. Christmas Tree Stand)**

- Seasonal Permit Application
- Site Plan
- Lease agreement or statement from property owner granting permission for seasonal operation(s)
- Application Fee (\$100.00 per a permit)

### **Site plan must include:**

Location of stand or tent (i.e. setbacks/right of ways)

Distance stand or tent is located from all streets, drives, road access, alleys.

Distance stand or tent is from any gasoline dispensing, pump, vent, or flammable liquid/gas.

Distance stand or tent is located away from hazardous accumulation of dry grass, brush, or other debris.
