INSTRUCTIONS

The purpose of the Individual Residential Lot Certification is to assist the Owner/Builder or Contractor to comply with the requirements of the Anderson County *Stormwater Management and Sedimentation Control* Ordinance Chapter 38, Article V, as it pertains to individual lots in a subdivision that have obtained prior permit coverage.

Failure to submit this certification will result in the requirement of an Owner/Builder or Contractor obtaining individual stormwater coverage pursuant to a separate permit that complies with the overall intent of the Larger Common Plan (LCP) of the subdivision.

Provided in this application are simplified details of a typical individual lot stormwater best management practices (BMP) application. You may direct any questions about or obtain assistance completing this application to the Anderson County Stormwater Management Department at 864-716-3620.
