2018 Holiday Market Vendor Policies

1. Holiday Market hours will be Thursday 5 pm – 8 pm (tentative) and Saturdays 10 am – 2 pm.
2. Vendors are asked to be set up and ready to sell by opening time each day and are asked to not pack up before the event closes. Market staff will be there no later than 8 am on Saturday and 3 pm on Thursday.
3. All vendors at the Holiday Market must complete and submit an application for the Market as part of the application process prior to being accepted as a vendor.
4. Booth assignments are not on a first come- first serve basis but are based on seniority, variety of products, and overall appeal of the Market. Due to the popularity of the Holiday Market there is not enough space for everyone to be under the shelter. You will be notified of your booth assignment prior to the first market.
5. All items must be grown, gathered, processed, or crafted by the vendor within 50 miles of Anderson County. Reselling of produce or other products is not allowed.
6. Individual vendors are responsible for obtaining all licenses, permits, and or exemptions required by DHEC, SCDA, SCDOR and any other city, county or state agencies.
7. The state of SC requires you to have a state tax ID number and requires you to collect sales tax. If you operate a full-time business, you should already have the necessary license. If you don't operate a full-time business, you can obtain a special retail license specifically for selling at craft shows. The fee for this license is \$20. Information and application can be found at <https://dor.sc.gov/tax/arts-and-crafts> .
8. Vendors will provide all necessary tables, chairs, tablecloths, scales, change, umbrellas or tents, bags for consumers, extension cords and display containers for their stall. No on-site storage is available for vendors. A limited number of tables are available on a first come first served basis.
9. Vendors are responsible for their own change and for collecting payment for their own products. Any exchanges and/or refunds are at the vendor's discretion.
10. A seller's vending space must not exceed the limits of their bay. Vehicles that protrude too far into the parking lot or cause other obstructions may have to be parked away from the vendor's space after unloading. Vendors are highly encouraged to be completely set-up before opening time
11. Each seller is responsible for clean-up of their selling area. Littering is prohibited and any trash should be disposed of properly. A broom, dustpan, and pick-up stick will be available for use.
12. Smoking is not allowed under the shelter.
